

HOUSE RULES

I - GENERAL CONDITIONS

1 - CONDITIONS OF ADMISSION AND RESIDENCE

To be allowed to enter, settle and stay on the campground, you must have been authorized to do so by the manager or his representative. He is obliged to ensure the good running and order of the campsite as well as compliance with the application of these internal regulations.

Staying at the **Barétous-Pyrénées campsite** implies acceptance of the provisions of these regulations and the commitment to comply with them. No one may take up residence there.

2 - POLICE FORMALITIES

Anyone who is to stay at least one night on the **Barétous-Pyrénées campsite** must first present their identity documents to the manager or their representative and complete the formalities required by the police.

Minors unaccompanied by their parents will only be admitted with written permission from their parents. Pursuant to Article R.611-35 of the Code on the Entry and Residence of Foreigners and the Right of Asylum, the manager is required to have the client of foreign nationality complete and sign an individual police form upon arrival. It must mention in particular: the surname and first names, the date and place of birth, the nationality and the habitual residence. Children under the age of 15 can be listed on one of the parents' forms.

3 - INSTALLATION

The tent or caravan and related equipment must be set up on the pitch indicated in accordance with the instructions given by the manager or his representative.

4 - RECEPTION DESK

Opening hours:

July and August: 8:00 am – 12:00 pm & 3:00 pm – 7:00 pm Saturday 8:00 am – 10:00 am & 3:00 pm 7:00 pm

Other periods: 9:00 am – 12:00 pm & 3:00 pm - 6:00 pm Sunday and Wednesday afternoon: Closed

Outside these hours and in case of absence, contact the caretaker: 06.49.98.27.13

At the reception desk, you will find all the information on the services of the campsite, information on the possibilities of refuelling, the sports facilities, the tourist attractions of the surrounding area and various addresses that may be useful.

A complaint book or a special box intended to receive complaints is kept at the disposal of users. Complaints will only be considered if they are signed, dated, as accurate as possible and relate to relatively recent events.

5 - FEES AND DEPARTURE TERMS

Fees are paid at the reception desk. The amount is displayed at the entrance to the campsite and at the reception desk. They are due according to the number of nights spent in the field.

Users of the campsite are invited to notify the reception office of their departure the day before it.

Campers will have to pay for their pitch on the day of their arrival.

The prices indicated are subject to change. The campsite reserves the right to change the rates at any time. Stays will be invoiced on the basis of the rates in force on the day of booking, subject to availability. It is advisable to check the applicable rate by contacting the campsite directly. Offers and promotions are not retroactive and cannot be combined with each other.

6 - NOISE AND SILENCE

Campground users are urged to avoid noise and discussions that could disturb their neighbours.

The sound equipment must be adjusted accordingly. Door and trunk closures should be as discreet as possible.

THERE MUST BE TOTAL SILENCE BETWEEN 11:00 P.M. AND 8:00 A.M.

7 - ANIMALS

Dogs are allowed on the campground under the following conditions:

Dogs are allowed in some rentals.

The owner must be able to provide the up-to-date vaccination record as well as a certificate of insurance against third parties as well as the tattoo card and the vaccination record.

They must never be left at large but must be kept on a leash

They are forbidden in public places such as sanitary facilities, reception, campers' room, swimming pool and in rental accommodation.

They must not be left at the campsite, even locked up, in the absence of their owners who are civilly responsible for them.

8 - VISITORS

After being authorized by the manager or his representative, visitors may be admitted to the campground under the responsibility of the campers who receive them.

The camper can receive one or more visitors at the reception. If these visitors are allowed to enter the campsite, the camper who receives them may be required to pay a fee, provided that the visitor has access to the services and/or facilities of the campsite (except the swimming pool). This fee is posted at the entrance to the campsite and at the reception desk.

Visitors' cars are not allowed in the campground.

9 - TRAFFIC AND PARKING OF VEHICLES

Inside the campsite, vehicles must travel at a speed limit of **10 km/h**

TRAFFIC IS PROHIBITED BETWEEN 10:30 P.M. AND 8 a.m.

During this period, vehicles must be parked outside, in the spaces provided for this purpose. Only vehicles belonging to campers staying there may circulate in the campground. Parking, which is strictly forbidden on pitches usually occupied by camping facilities, must not obstruct traffic or prevent the installation of new arrivals.

10 - HOLDING AND APPEARANCE OF INSTALLATIONS

Everyone is required to refrain from any action that could harm the cleanliness, hygiene and appearance of the campsite and its facilities, including sanitary facilities

It is forbidden to throw waste water on the ground or in the gutters.

Caravanners and motorhome owners must empty their wastewater in the facilities provided for this purpose.

Household waste, waste of all kinds, and paper must be placed in the bins.

Washing is strictly forbidden outside the bins provided for this purpose.

Laundry will be hung in the common dryer if necessary. However, it is tolerated for up to 10 hours near the shelters, provided that it is very discreet and does not disturb the neighbours. It should never be made from trees.

Plantings and floral decorations must be respected. It is forbidden for the camper to drive nails into trees, cut branches, or plant.

It is also not permissible to demarcate the site of a plant by personal means, nor to dig the ground.

Any damage to the vegetation, fences, land or campsite facilities will be the responsibility of the perpetrator.

The pitch, which will have been used during the stay, must be maintained in the condition in which the camper found it when he entered the premises.

11 - SECURITY

A first aid kit can be found at the reception desk.

A - Fire

Open fires (wood, coal, etc.) are strictly prohibited.

Stoves and barbecues must be kept in good working order and not used in hazardous conditions.

In the event of a fire, notify management immediately. Fire extinguishers can be used if necessary.

B - Theft

The management is responsible for the objects deposited at the office and has a general obligation to supervise the campground. The camper retains responsibility for his own installation and must report to the manager the presence of any suspicious person.

Although security is provided, campground users are invited to take the usual precautions to safeguard their equipment.

12 - GAMES

No violent or awkward games may be organized near the facilities.

The entertainment room cannot be used for hectic games.

CHILDREN SHOULD ALWAYS BE UNDER THE SUPERVISION OF THEIR PARENTS.

13 - DISPLAY

These rules of procedure are posted at the entrance to the campsite and at the reception desk. It is given to the customer at his request.

14 - DEAD GARAGE

Unoccupied equipment may only be left on the site after the agreement of the management and only in the location indicated. This service may be subject to a fee.

15 - VIOLATION OF THE INTERNAL REGULATIONS

In the event that a camper disrupts the stay of other users or does not comply with the provisions of these internal regulations, the manager or his representative may, orally or in writing if he deems it necessary, give notice to the latter to cease the disturbance. In the event of a criminal offence, the manager may call in the police.

II - SPECIAL CONDITIONS

1 - SWIMMING POOL

Access to and use of the swimming pool are subject to specific regulations applicable from the date of its commissioning, i.e. 1 July 2000. The use of the swimming pool is strictly forbidden to people outside the campsite, including visitors.

2 - ANIMALS

In accordance with article 211.1 of the Rural Code, and the decrees and ministerial orders of application, dogs of the 1st category "attack dogs" (pit bulls) are prohibited. Dogs in the 2nd category "guard and defense" (Rottweiler and types...) must be muzzled and kept on a leash by an adult in the campsite.

3 - MINORS

Minors with written authorization from their parents will be under the responsibility of an adult accompanying them.

The sale and consumption of alcohol is strictly forbidden to minors.

4- USE OF THE BARBECUE

Electric, gas or charcoal barbecues are allowed on the campsite

On the other hand, the use of flammable liquid is forbidden as well as dry branches or leaves.

The installation must respect a safety distance of at least one metre from facades, terraces, structures and separating hedges.

Barbecues are forbidden on the terraces under penalty of a 300€ deposit.

5-VISITORS.

When the reception is open, each visitor must present themselves at the reception.

No visitors are allowed to enter the campsite unless previously authorised by the management.

If the management is closed, contact the telephone number indicated on the reception door.
